
Pembroke Lakes Elementary PTA PELICAN PARTNERSHIP PACKAGES 2025/2026

Banners should not be construed as advertising. Banner displays will expire on June 30 of the following school year. Banners that have not been claimed by the second week of September will be discarded. All banners must comply with district policies, including Policy 1930. If policies change and banners no longer comply, they will need to be replaced.
